**4<sup>TH</sup> NATIONAL SUMMIT ON DIMINISHING CORRUPTION IN THE PUBLIC SECTOR/2022 PUBLIC SERVICE INTEGRITY AWARD: CALL FOR NOMINATION**

The Independent Corrupt Practices and Other Related Offences Commission (ICPC) in collaboration with the Office of the Secretary to the Government of the Federation (OSGF) is organizing the 4<sup>th</sup> edition of the Annual National Summit on Diminishing Corruption in the Public Sector/ 2022 Public Sector Integrity Award.

2. The National Summit is designed to review and update efforts in the fight against corruption, especially in the public sector. In an effort to entrench integrity in the public sector, a significant feature of the summit will be the presentation of Public Service Integrity Awards to deserving Federal public servants who have performed exceptional acts of integrity in the year.

3. Accordingly, all Ministries, Departments and Agencies are requested to **forward one nomination each to ICPC** in the form of (i) the profile of the nominee as well as (ii) a brief description of the acts of integrity carried out by the officer in not more than 500 words, **not later than 31<sup>st</sup> July, 2022.**

4. The best two (2) nominees will be screened and presented to Mr. President for the award presentation at the National Summit.
