GUILDELINES ON CONDUCT OF OFFICIAL TRAVELS BY CABINET MEMBERS, HEADS OF AGENCIES AND PUBLIC OFFICIALS

Further to the various government directives and extant regulations issued to guide and restrict the conduct of official travels outside the country and related matters, the observed non-compliance to these extant rules on travel restriction has become worrisome, which is inimical to the image of government as well as counterproductive to the promotion of the much-desired economic development and service delivery.

2. Mr. President has therefore directed that the contents of all extant rules aimed at instilling fiscal discipline and prudence especially in the area of official travels be re-emphasised as Government would no longer tolerate the flagrant abuse of its directives. Therefore, the contents of the underlisted extant Circulars needs emphasis.

- 3. Additionally, Mr. President has directed the suspension of international travels by all Cabinet Members and Heads of Government Agencies at the commencement of Annual Budget defence at the National Assembly, considering the need for the Executive Arm of Government to provide the necessary cooperation to ensure timely passage of the Appropriation Bill. Cabinet Members are to personally lead the process of budget defence at the National Assembly.
- 4. Any Minister embarking on foreign travel must provide documented justification for such trip to obtain Mr. President's approval in writing and leave the details of his/her place of stay abroad in case of any need to contact him /her.
- 5. The processing of all requests for approval to travel out of the country must conform with the provisions of extant regulations and guidelines before the required approval is granted, and the applications must be made at least two weeks before the expected date of departure to enable the approving authority ample time to consider the request on merit.

6. All Honourable Minsters, Permanent Secretaries /Accounting Officers are to ensure strict compliance with the contents of this Circular.
